### **Correspondence Received:**

- Fleur de Farias, Team Coordinator of SouthCity Soundz, spoke to the floor about the Revitalisation programme that her Chorus has been taking part in during the past year.
- They were approved for this Programme by International with the support of the Regional Management Team and have now completed one year in the Programme.

- The chorus has received RMT visits from Miriam (Membership), Jo (Marketing), Leanne (Education) and Carolyn (Directors') as part of the support package for a chorus in Revitalisation.
- The chorus is gaining in size slowly and they have applied for another year in the programme. They are unable to compete due to numbers but are still enjoying the opportunities to sing.
- Thank you to the RMT for support and assistance during this time.
  
- Stella Nicholson, Finance Coordinator from Dunedin Harmony, had written to the RMT expressing the chorus's disappointment on not being notified of convention moving to their city next year prior to the announcement in the Team Talk of March this year. Leigh had earlier explained the circumstances of the decision process for moving convention 2024 from Auckland to Dunedin, in her report and had apologised to the Dunedin Harmony Chorus for this misstep. She reiterated her apology and Stella acknowledged the apology and further discussion was held on the necessity to communicate to host city choruses in the future, prior to convention locations being established.
